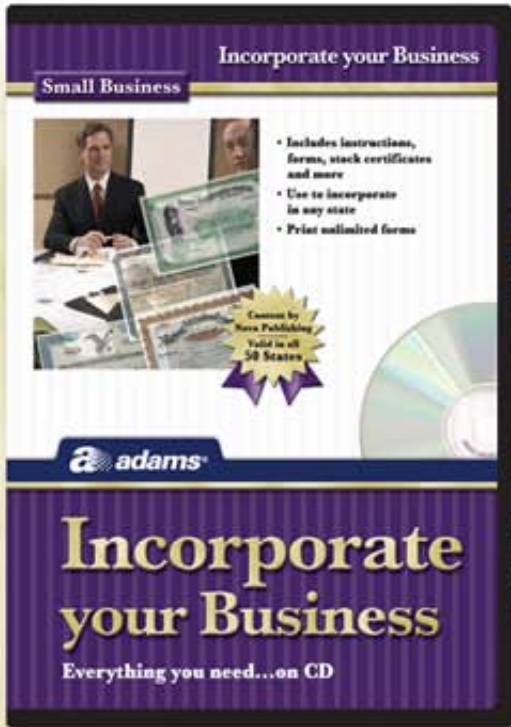

But the most important advantage to the corporate form of business structure is the potential limited liability of the founders of and investors in the corporation. The liability for corporate debts is limited, in general, to the amount of money each owner has contributed to the corporation. The personal assets of the owners are not at risk if the corporation fails.
