

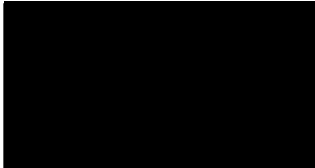



As specified in European standard on safety of toys EN71 PART 3 : 1994 +A1:2000 – Migration of certain element were performed by Atomic Absorption or Inductively Coupled Argon Plasma Spectrometry.
